2. Minutes of previous Annual General Meeting

The Minutes of the Annual General Meeting held on 11 November 2020 were confirmed as a correct record. (*Moved R Refshauge, seconded G McCarthy*)

3. Matters arising from the Minutes: Nil

4. President's Report

The President of the Institute, Geoffrey McCarthy, reported on the activities of the National Executive Committee in 2020-2021. He noted that while COVID-19 has presented has another challenging year for the AIAL in meeting its core mission, the pandemic has in many ways transformed the way the Institute carries on its activities, some for the better and some less so. The Institute remains in a sound position, operatively and financially, and has benefited from the transformation of the National Executive Committee with the election of members from outside Canberra. He reported on the *Forum* publication, the 2021 National Conference which was cancelled for a second year as an in-person event but successfully transformed into a series of

webinars and looked ahead to the 2022 AIAL National Conference to be conducted under the theme of *Administrative Law in Unprecedented Times*.

He thanked all members of the NEC noting in particular Gary Humphries AO and Robert Orr QC, for their guidance and support during the year, and the support of the AIAL Secretariat staff at Commerce Management Services.

Outcome: The President's report was accepted.

5. Treasurer's Report

The Treasurer of the Institute, Paul Pfitzner, spoke to the audited financial statements for the Institute for the 2020-2021 financial year. He noted that this will be his last report as Treasurer of the AIAL with Gary Humphries nominating for the Treasurer's role.

The financial position of the AIAL was impacted by COVID-19 in 2020 and the consequential cancellation of the National Conference.

On a national basis, the AIAL recorded a loss \$28,652k as a consolidated entity for FY2021 as a direct result of the conference cancellation. However, the organisation remains in a strong financial position overall with \$306,721 cash on hand as a consolidated entity (of which \$122,677 is held in National cash deposits).

It is anticipated that the Institute will record another loss in FY2022 following a second year in which the conference was cancelled as an in-person event. Some revenue was received from the webinar series but significantly less than from the conference. The Victorian Division agreed to provide up to \$10,000 to offset losses from the cancellation of the event.

The Treasurer confirmed that the Institute is in a position to withstand a further loss on FY2022 due to prudent financial management in past years.

He noted the business improvements implemented during the year by the Secretariat including a move to online banking and a different accounting platform.

The work of the Secretariat and the Auditor was acknowledged.

Resolution: The Treasurer's Report was accepted, and the audited financial statements and Auditor's Report were accepted. (*Moved G McCarthy, seconded R Refshauge*)

6. Appointment of Auditor

Resolution: Anthony Curtis & Co was appointed auditor for the 2021-2022 financial year. (*Moved P Pfitzner, seconded G McCarthy*)

7. Election of Officers

The Chair vacated the Chair in favour of the appointed Returning Officer, Peter Sutherland.

8. Notice of Motion: Membership Fees for 2020/2021

The Chair spoke to this item, noting the previously circulated Notice of Motion and the following background:

At the 2018 AGM approval was given for the AIAL membership fees to be increased by approximately 10% for the following three financial years (2019-20; 2020-21; 2021-22) to better align the income from membership fees with the cost of administration of the Institute and the cost of providing a print copy of the *AIAL Forum* to financial members as part of their membership subscription.

The first of the three increases (for the financial year 2019-2020) was implemented.

In light of the COVID-19 pandemic, the National Executive deferred the second fee increase intended to be implemented for the financial year 2020-21. It did so again for the financial year 2021-22. The proposed resolution for this AGM would implement the second of the three progressive increases agreed in 2018. Members can expect the third of the three progressive increases to be implemented for the financial year 2023-2024.

Resolution

That the membership fees for the 2022-2023 financial year be increased from \$330.00pa to \$365.00pa for organisations, from \$110.00pa to \$120.00pa for individuals, from \$45.00pa to \$50.00pa for students or those not engaged in paid employment, and from \$140.00pa to \$155.00pa for libraries. (*Moved G McCarthy, seconded R Pepper*)

Australian Institute of Administrative Law

President's Report to Annual General Meeting

24 November 2021

The Covid 19 pandemic has caused a challenging year for the Institute. It has in many ways transformed the way it carries on its activities, but I am pleased to say that the Institute remains in a sound position, operatively and financially.

I should begin by commenting on the transformation of the National Executive Committee itself. In broad terms, the Institute's origins lie with several pre-eminent Canberra-based administrative law lawyers, for example Robert Todd, Dennis Pearce, John McMillan, Stephen Argument, Robin Creyke, Geoff Kolts, Derek Emerson-Elliott and Michael Sasella among others, who came together in 1989 and agreed to establish the Institute. Details about the Institute's origins can be found in Robert Orr's article in *AIAL Forum 100*.

Incorporation followed, including establishment of an executive committee drawn from Canberra-based lawyers who met once a month to administer the affairs of the Institute. In time, State Chapters of the Institute were formed to enable the activities of the Institute to be carried on across the country.

For no deliberate reason, and perhaps simply to enable monthly meetings to occur in a convenient and cost-free manner, the NEC continued to be made up of Canberra-based members.

At the last AGM, that structure was transformed. Members of the NEC were appointed from NSW, Victoria, Queensland and South Australia. A little later in the year, Mr Arran Gerrard from the Institute's WA Chapter also joined the NEC.

Prior to last year's AGM, monthly NEC meetings occurred around a table shortly after business hours. I record the NEC's thanks to Clayton Utz, Canberra, who made available their boardroom and provided refreshments at no charge. After last year's AGM, consequent upon the election of six interstate members, NEC meetings occurred using Clayton Utz's video link facility and later via Zoom to facilitate participation by its interstate members. Later in the year, the Canberra-based members of the NEC also participated by Zoom for reasons of convenience.

In my view, and I think I speak for all the members of the NEC, the change to membership of the NEC from different parts of Australia has been a success. It has given the Institute a more outward focus. It has created a better system for sharing knowledge about developments in administrative law at the State level. It has created opportunity for better connection with the State Chapters. It has given impetus to receiving contributions from wider sources to *AIAL Forum*.

That nominations for election to the NEC at tonight's AGM were received from persons living in NSW, Victoria, Queensland, Western Australia and South Australia, and that most were from persons from the existing NEC who have generously agreed to re-nominate, suggests that this transformed national structure has been a success and will continue.

The change also raises many questions about how the Institute should function, administratively, in relation to the State Chapters. For example, should interstate members of the NEC also be members of their respective State Chapter committees in order to provide convenient lines of communication between the NEC and the State Chapters? For similar reasons, when electing members of the NEC, should there be a system to facilitate representation from each State Chapter? What should be the ongoing role of the National Council, having regard to interstate membership of the NEC? I have written to the Chair of each State Chapter, seeking their views on these issues. They are issues to resolve in the coming year.

I turn now to the activities of the Institute over the past 12 months.

AIAL Forum

The Editorial Board continued to be made up of Professor Robin Creyke AO as chair, Dr Geoff Airo-Farulla, Tara McNeilly and Peter Woulfe. Kirsten McNeill continued her role as our excellent editor. Publication is arranged by Sue Hart of Commerce Management Services, the Institute's secretariat, who has continued to deliver excellent service.

During this year, the NEC determined to move from four publications of *AIAL Forum* to three, over a 12 month period. This was prompted primarily by a need to rationalise publication costs. In the past, these costs were met by revenue generated from attendances at the Institute's annual national conference. The Institute has been without that revenue for two years consequent upon the need to cancel the conference because of the Covid 19 pandemic.

During this year, publication of *Forum* moved into its next century, by publication of *Forum 101*, published in March 2021 and *Forum 102*, published in July 2021. For several reasons, particularly the efforts of members of State Chapters, both editions contain a wide range of articles of a high standard. Many articles address the increasingly important subjects of integrity, human rights, accountability and the public interest.

Publication of *AIAL Forum 103* is close to finalisation and will be published shortly. It will contain papers from the 2021 National Conference.

2021 AIAL National Administrative Law Conference

The 2021 AIAL National Administrative Law Conference, postponed from 2020, was due to be held in Melbourne on 22-23 July 2021, hosted by the Institute's Victorian Chapter. The theme of the conference was 'Administrative Law on the Edge'. An excellent program was developed by the Melbourne conference committee, led by Emma Turner, but unfortunately it was again not possible to hold the conference in person due to the COVID 19 pandemic.

A difficult decision was taken by the National Executive and the Victorian Chapter, together, instead to hold the conference via a series of Zoom webinars, commencing on 22 July 2021 and ending on 12 August 2021. All of the plenary sessions originally planned for the conference were able to run in this way and were very well received.

The opening address for the Conference was by given Justice Kirsten Walker of the Tory and Court of Appeal who discussed issues for courts arising from the Covid 19 pandemic. Justice Rachel Pepper of the NSW Land and Environment Court who gave a paper on environmental rights. Dr Will Bateman of the ANU who gave a paper on artificial intelligence and automation. Peter Hanks QC of the Victorian Bar who gave a paper on the so-called Robo-debt scandal, and Professor Matthew Groves of Deakin University who gave the National Lecture on the role of the Attorney-General. There were many other excellent papers given online.

It is a testament to the efforts of many, particularly the Institute's secretariat, Commerce Management, that a two-day conference was able to 'pivot' to an on-line format in a very short timeframe.

It is a comment on a perhaps unexpected benefit of Covid 19 that the delivery of the conference by webinar enabled high attendance from all parts of Australia at minimal cost to attendees. That said, some lament the absence of an in-person gathering at the national conference that enables a greater sharing of ideas about administrative law, which is one of the Institute's important purposes.

Another perhaps unexpected benefit of the online format is that the NEC's decision to permit members to attend webinars without charge, where non-members pay a fee, appears to have led to a notable increase in Institute membership.

2022 AIAL National Administrative Law Conference

Planning work is well underway for the 2022 AIAL national conference to be held at the Hotel Realm in Canberra on 21-22 July, 2022. The proposed theme for the conference is 'Administrative law in unprecedented times'. A "call for papers and save the date" flyer has been prepared and will be distributed in the coming days.

As is apparent from the proposed venue, the Institute proposes to return to an in-person format, in the interests of enhancing connection between persons who work in the area of administrative law.

I encourage members to attend, and to promote the conference in the interests of its success and of the Institute itself.

Seminars and webinars

Since the last AGM in November 2020, many seminars and webinars have been held on a broad range of topics. The AIAL's webinar program has remained very popular and can be viewed by members and others across Australia. I acknowledge Jaala's Hinchliffe's considerable efforts, as a member of the NEC, in organising and publicising the program.

The substantial contribution made by State Chapters to the program is noteworthy.

- 'The Human Rights Act 2019: Three Tricky Questions for Administrative Lawyers', presented by Felicity Nagorcka, Assistant Chief Counsel – Crown Law and chaired by Gail Hartridge, Barrister – Wilberforce Chambers, on 26 October 2021.

Planning work is underway for various seminars and webinars to be held in the first half of 2022.

AIAL project grants

In past years, the Institute has provided financial support for different kinds of projects, particularly publications, in the interests of promoting understanding and development of administrative law. Regrettably, and as one of the setbacks of the Covid 19 pandemic, the NEC determined not to make grants during the past 12 months in the interests of fiscal responsibility.

AIAL website

Over the last year, the AIAL website has been successfully moved from an Adobe platform, which is no longer supported, to a Wordpress platform. The website is now hosted by Sydney based Cornerstone Web Solutions. Arrangements have also been made for WebAware to provide ongoing back-end support to the website. They are also setting up a video capability which will provide an avenue for the dissemination of webinar recordings. The website seems to be working well and is at: aial.org.au. The AIAL twitter account remains active in advertising seminars and other AIAL events and is at: AIAL@AIALpubliclaw.

Richard Hart and Sue Hart from the secretariat have assisted greatly with management of the website, together with Robert Orr, Peter Sutherland and Margaret Tregurtha.

We hope that over the next year our IT support providers we will have helped us develop a new 'theme' for the website, which will customise the appearance of the site, including its layout, typography, and other design elements. The change of theme is also necessary because the current theme is running in PHP 7.4 which will not be supported beyond October 2022. We also hope to add to the content on the site, including scanned versions of the predecessor to *AIAL Forum*, the AIAL Newsletter, and other material.

All editions of the *AIAL Forum* are now on the website, but most are not in searchable form. We hope to increase the number of editions in searchable form over the next year.

In the Victorian Chapter, Emma Turner was president, Jeffrey Barnes, secretary and Maria O'Sullivan, treasurer.

In the NSW Chapter, Justice John Basten was president, Justice Rachel Pepper, secretary and Andrew, Carter, treasurer.

NOTICE OF SPECIAL RESOLUTION TO AMEND THE AIAL RULES

The following motion to amend the Rules of the Australian Institute of Administrative Law Incorporated (AIAL) - A1733 (ACT) (AIAL Rules) will be moved at the Annual General Meeting of the AIAL to be held at 5:30pm (AEDT) on Thursday 10 November 2022.

The motion will be moved as a special resolution.

Special Resolution

Motion: That the AIAL Rules be amended as follows:

- 1. Amend subrule 2(1), the definition of "special resolution", paragraph (b), by substituting "vote at the meeting in person or by proxy" with "are present in person or by proxy and vote".
- 2. Amend subrule 18(2) by substituting "No cheques shall be drawn on" with "No funds shall be withdrawn from".
- 3. Omit subrule 18(3) and substitute the following:
 - "All withdrawals of funds from the Institute's bank account or accounts shall be made by such person or persons as the Executive has from time to time nominated for that purpose."
- 4. Amend subrule 32C(2)(b) by substituting "2 representatives" with "a representative".
- 5. Omit rule 32D and substitute the following:
 - **"32D.** The functions of the National Council are to make suggestions and recommendations to the Executive as to the activities and future directions of the Institute."
- 6. Omit subrule 32E(2) and insert the word "OMITTED"
- 7. Omit subrule 32E(3) and substitute the following:
 - "If a meeting is convened under subrule (1), the President should try to ensure it is held during and at the same location as the next scheduled administrative law forum".

Amendments to AIAL Rules - Explanatory Statement

- 1. The proposed amendments to the Rules of the Australian Institute of Administrative Law Incorporated (AIAL) A1733 (ACT) (ACT Rules) are to achieve three things.
- 2. First, the proposed amendment to subrule 2(1), the definition of "special resolution", paragraph (b), is to utilise the definition of "present in person" in subrule 2(1) to make clear that for the purposes of passing a special resolution, a person entitled to vote may vote by attending in person by any of the means stated in the definition, or by proxy. The means stated in the definition of "present in person" include by an internet or intranet link, by a telephone link, by being physically present, or by a combination of these.
- 3. Second, the proposed amendments to rule 18 are to remove references to payment by cheque, so as to permit electronic payments, but to maintain the requirement that all withdrawals from Institute bank accounts (i.e. payments) are authorised and made by a person or persons authorised to make them.
- 4. Third, the proposed amendments to rules 32D and 32E are to address the changed circumstances of the National Council.
- 5. The proposed amendments to rule 32D are to remove reference to the Council recommending membership fees and the use of membership fees, about which the National Council has not, at least in recent years, made recommendations, and to recast its role as an advisory or policy role regarding the activities and future directions of the Institute.
- 6. The proposed amendments to rule 32E are to remove the need for an annual meeting of the National Council in circumstances where, it is hoped, at least 1 representative from each Chapter of the Institute will be a member of the Executive as is presently the case. Assuming that continues, the functions of the National Council can be adequately and more regularly performed by participation of the Chapter representatives at monthly Executive meetings.
- 7. The proposed amendments to rule 32E preserve, however, the option of convening a National Council meeting at any time to cater for future non-representation of a Chapter on the Executive or for any other reason.
- 8. The proposed amendments to subrule 32E(3) are to continue the convenience and advantages for participants in a meeting of the National Council, where possible and appropriate, that can be achieved by holding the meeting to coincide with an annual conference.

NOTICE OF RESOLUTION TO INCREASE MEMBERSHIP FEES FOR 2023-2024

The following resolution to increase membership fees with effect from 1 July 2023 will be moved at the Annual General meeting of the Australian Institute of Administrative Law to be held at 5.30pm (AEDT) on Thursday 10 November 2022. The resolution arises from rule 7 of the AIAL Rules, which provides:

Membership fees

- **7.(1)** The membership fees for a financial year are the amounts that the members determine from time to time at an annual general meeting for the following classes of members
 - (a) an organisation;
 - (b) an individual (other than a student or a person who is not engaged in paid employment);
 - (c) a student or a person who is not engaged in paid employment;
 - (d) a library.

Resolution

That the membership fees for the 2023-2024 financial year be increased from \$365.00pa to \$400.00pa for organisations, from \$120.00pa to \$130.00pa for individuals, from \$50.00pa to \$55.00pa for students or those not engaged in paid employment, and from \$155.00pa to \$170.00pa for libraries.

Rationale

Approval was given at the 2018 AGM that the AIAL membership fees be increased by approximately 10% for the following three financial years (2019-20; 2020-21; 2021-22) so that the income from membership fees is in balance with the cost of administration of the Institute and the cost of providing a print copy of the *AIAL Forum* to each financial member as part of their membership subscription. The student membership fee provides access to an electronic copy of the *AIAL Forum* but does not include a print copy.

The first of the three increases (for the financial year 2019-2020) was implemented.

In light of the COVID-19 pandemic, the National Executive deferred the second fee increase intended to be implemented for the financial year 2020-21. It did so again for the financial year 2021-22. The second of the three progressive increased was implemented in 2022-23. The proposed resolution, if passed, will implement the third of the three progressive increases for the financial year 2023-2024.
